WSKRA was formed in March 1999 following a meeting of 100+ residents at the former local RSL club on Loch St. and registered with Consumer Affairs Victoria as an incorporated association in June 1999. In October 2024 we were proud to celebrate our 25 years of continuous service.

All current members of the Association keen to help preserve and enhance our community are welcome to nominate to the Committee at any time. The Committee meets 4 or 5 times each year. Please talk to a current committee member for more information.

GRAND PRIX - ALBERT PARK RESERVE

The Victorian State Government will start upgrading pit lane facilities after the 2026 race, adding 7 indoor sports courts and improved amenities for outdoor field clubs as well as upgrading to the event spaces. In the meantime, there has been state government legislation proposed to extend the official closure period for Albert Park Reserve from 1 week to 3 weeks around the Grand Prix and to allow AGPC to use of the facilities outside of the times of the Grand Prix. There has been a great deal of local discontent around this proposal including the lack of detail around noise and nuisance policies and guidelines and use of State Government funds to support the Grand Prix.

There are two main avenues for complaints about the Grand Prix: Australian Grands Prix Corporation (03) 9258 7100 or communityrelations@grandprix.com.au or the City of Port Phillip. Complaints can also be directed to the Victorian Ombudsman, www.ombudsman.vic.gov.au

Let us know if the Grand Prix has impacted you through changes to public transport, noise (including helicopter joy rides), parking, or traffic. WSKRA will forward your concerns to the myriad of relevant authorities.

ALBERT PARK BRANCH SEWER UPGRADE DEAKIN AND COWDEROY STREETS WORKS – SE WATER

According to the official website, Stage 2 is projected for completion by mid-October 2025. Although we cannot be sure that the detours around Deakin and Cowderoy Streets will be removed by then. Later stages are scheduled, with all works anticipated to be finalised by mid-2026. JACOBY PARK

Jacoby Park is a much-utilised park in the neighbourhood and has been looking a bit tired for some time. WSKRA Committee met with Councillor Rod Hardy to press for a renovation of the park and ongoing maintenance. We need an upgrade of planting and removal of woods, replacement of rusted play equipment and improved lighting for community safety.

PEAK HOUR TRAFFIC CONGESTION

The six-month trial of a No Right Turn from Canterbury Rd to Cowderoy St during peak hours closed last year. Residents had noticed a marked reduction in traffic congestion and dangerous driving so it was disappointing that our then Councillors decided to call the trial unsuccessful, contrary to the official report from Council traffic engineers!

The Council discontinued the trial without putting forward an alternate solution, setting us back to the same sorry situation suffered by residents over many years: peak hour traffic congestion on our minor streets and the dangerous rat racing that it encourages. WSKRA will continue to press Council for a solution to this long-standing, high-priority community issue.

THE BEACONSFIELD HOTEL

The Beaconsfield Hotel is an acknowledged part of our neighbourhood. The historic pub has been largely vacant and deteriorating over the past years.

Community response to the planned reopening has been largely positive, however there are concerns about how the hotel will affect residents who live close by. Questions have been raised regarding parking, hours of operation, noise solutions, and refurbishment investment. The application (Planning Permit PDPL/00334/2023 for 341 Beaconsfield Parade) will be heard by VCAT mid-year.

SHRINE TO SEA PROJECT

Residents will have noticed several bits of street and median strip work being undertaken in Kerferd Road lately. This work is all part of the Shrine to Sea upgrade of the boulevard linking the Anzac Station to Kerferd Road pier and Albert Park beach. ADDRESSING HOONING

WSKRA together with other resident groups, councils and police were members of the State Government Hooning Reference Group. Mitigation recommendations supported by the group were agreed and forwarded to State Government for action; specifically, the introduction of acoustic cameras and on-the-spot noise testers. We understand that it is to be trialled shortly, when responsibilities for oversight, monitoring and enforcement are determined.
